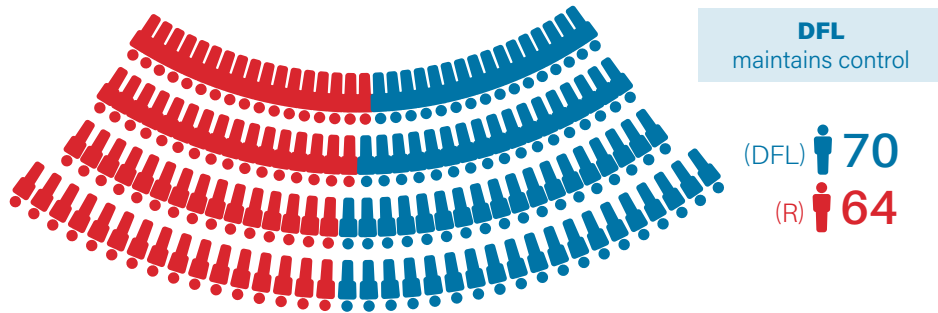


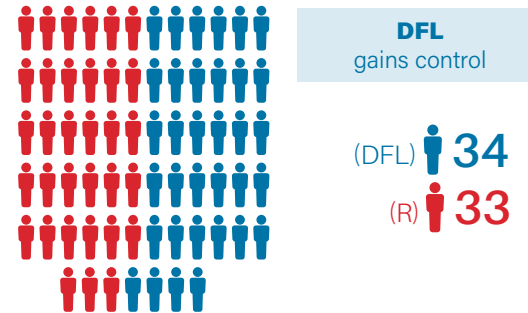


# 2022 Minnesota Election Scorecard

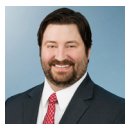
